

# **External Trade of Macao in the First Quarter of 2023**

## **Overview**


External merchandise trade of Macao totalled MOP38.79 billion in the first quarter of 2023, down by 7.7% from the MOP42.03 billion in the same quarter of 2022. Merchandise imports contracted by 6.6% to MOP35.64 billion and merchandise exports went down by 18.7% to MOP3.15 billion. The exports-imports ratio decreased by 1.4 percentage points year-on-year to 8.8%. Merchandise trade deficit narrowed from MOP34.28 billion in the first quarter of 2022 to MOP32.48 billion.

## **Total Exports**

Total merchandise exports fell by 18.7% year-on-year in the first quarter of 2023, with domestic exports and re-exports dropping by 38.6% and 15.7% respectively.

Analysed by destination, merchandise exports to India (MOP18.0 million) and Viet Nam (MOP42.1 million) expanded by 39.4% and 34.7% respectively. On the other hand, exports to Singapore (MOP19.2 million), the USA (MOP70.8 million), the EU (MOP26.9 million), mainland China (MOP186.5 million) and Hong Kong (MOP2.48 billion) slipped by 55.1%, 51.9%, 48.4%, 33.0% and 19.9% respectively.

Exports of machines & apparatus, parts & accessories thereof, the leading export commodity, increased by 26.9% to MOP625.7 million, accounting for 19.9% of the total exports. Exports of tobacco & wine swelled by 45.6%, whereas exports of watches, diamond & diamond jewellery, copper & articles thereof, garment & textile products and electronic components shrank by 51.6%, 50.0%, 41.8%, 30.8% and 20.2% respectively. By contrast, exports of other products rose by 3.8%.



## Domestic Exports

Domestic exports amounted to MOP309.6 million (9.8% of total exports), down by 38.6% year-on-year and 37.0% quarter-to-quarter. Hong Kong was the largest market of Macao's domestic exports (35.5% of total domestic exports), with the corresponding value of exports dropping by 12.7% year-on-year. Value of exports to India and Viet Nam rose by 39.4% and 18.4% respectively, while that to Singapore, Canada, the EU, the USA and mainland China declined by 68.4%, 61.2%, 51.7%, 51.4% and 37.0% respectively. Analysed by type of commodity, exports of garments (16.6% of total domestic exports) slid by 64.3%, of which exports to the USA (86.9% of total domestic exports of garments) and Hong Kong (8.2%) shrank by 63.1% and 59.7% respectively. Exports of tobacco (9.0% of domestic exports) went up by 65.9%; meanwhile, exports of copper & articles thereof (23.1%) and other products (51.3%) dipped by 42.2% and 27.7% respectively.

Domestic exports to mainland China fell by 37.0% to MOP43.7 million (14.1% of domestic exports), of which tariff-free merchandise exports under the Mainland and Macao Closer Economic Partnership Arrangement (CEPA) decreased by 4.4% to MOP19.9 million, consisting mainly of copper-clad boards (74.1% of total). The amount of tariff saved totalled MOP980 thousand.

## Re-exports

Total value of re-exports decreased by 15.7% to MOP2.84 billion (90.2% of total exports) in the first quarter of 2023. Hong Kong was the largest market of Macao's re-exports (83.5% of re-exports), followed by mainland China (5.0%). Value of re-exports to Viet Nam grew by 58.9%, while that to mainland China and Hong Kong declined by 31.7% and 20.2% respectively. In terms


of types of commodities, re-exports of consumer goods (58.6% of re-exports) and raw materials & semi-manufactures (2.4%) reduced by 33.7% and 27.1% respectively; on the other hand, re-exports of other products (38.9%) rose by 44.9%.

## **Imports**

Total value of merchandise imports fell by 6.6% year-on-year to MOP35.64 billion in the first quarter of 2023. The EU was the main supplier of goods imported to Macao (34.7% of total imports), and the value of imports dropped by 13.4% to MOP12.37 billion. As regards other places of origin, value of imports from Hong Kong (4.4% of imports) rose by 22.1%. By contrast, value of imports from United Kingdom (1.5%), Japan (5.7%), the USA (5.5%), mainland China (26.6%) and Switzerland (7.5%) diminished by 26.8%, 18.2%, 16.4%, 13.7% and 9.6% respectively.

Regarding the types of commodities, imports of raw materials & semi-manufactures (6.9% of total imports) and fuels & lubricants (4.1%) climbed by 3.3% and 2.8% respectively, whereas those of capital goods (12.1%) and consumer goods (76.9%) decreased by 29.4% and 3.0% respectively.

Imports of consumer goods showed a year-on-year decline; imports of beauty, cosmetic/skin-care products (9.9% of total imports), watches (7.0%), motor cars & motorcycles (1.0%), clothing & footwear (9.7%) and handbags & wallets (9.0%) dropped by 43.3%, 13.4%, 12.8%, 10.3% and 1.7% respectively, whereas imports of food & beverages (16.8%) and gold jewellery (9.7%) expanded by 46.3% and 22.0% respectively. In addition, imports of other consumer goods (13.7%) rose by 4.9%.
