CEPA has come into effect for about one yea; the economic and trade cooperation between the Mainland and Macao has come to a new level with institutionalized and all-round cooperation. In addition, with the completion of the Cross-border Industrial Zone and the joint development of Hengqin Island, it is believed that under the framework of CEPA, the economic and trade cooperation between the two places in the future will showcase an innovative collaboration mechanism resulting in further development on both sides. We wish that in the coming year all Macao manufacturers and service suppliers could have ample rooms for development by taking advantages of the business opportunities brought about by CEPA.

### 1. The Signing of Supplement to CEPA broadens and enriches the scopes of liberalization

The implementation of "the Mainland and Macau Closer Economic Partnership Arrangement" (also known as "CEPA") has played a significant role in promoting the

economic and trade development in the Mainland and Macao. Based on the open-ended nature of CEPA, the Government of the Macao SAR engaged in

consultations on broadening the scopes of CEPA in July. After four rounds of senior official meetings, the Supplement to CEPA was signed on 29<sup>th</sup> October in Macao.

The content of Supplement to CEPA covers trade in goods and trade in services:

Trade in Goods: the Mainland has agreed upon the application of zero tariffs on a second batch of 190 goods of Macao origin under trade in goods, which include:

- 124 products already produced in Macao can enjoy the zero tariffs benefit from 1<sup>st</sup> January 2005, provided that they comply with the CEPA 'Rules of origin'.
- 66 products that are planned for production, after being put into production by the applicant companies and approved by the Macao Economic Services and the Ministry of Commerce of the PRC, can be exported to China with zero tariffs.

Trade in Services: the Mainland expands 11 of the 18 already liberalized service sectors in the first phase of CEPA. Furthermore, entry requirements and shareholding ratios have also been relaxed. For the 8 newly opened service sectors, the Mainland has included commitments that its has not committed to the WTO for Macao Service Suppliers. Moreover, the number of geographic locations and the scopes of businesses in which individually owned stores can be established and operated in the Mainland have been increased, so that Macao SMEs can benefit more from the expansion.

### 190 additional products with zero-tariffs

Food and beverages, chemical products, photographic and developing products, textiles and clothing, leather and its products, stone materials and stone products, metallic products, electrical and electronic products and others (e.g. brooms, typing machines or ribbons, etc.)




# 2. Guangdong and Macao officials held the Joint Cooperation Conference in Guangzhou exploring further cooperation under the framework of CEPA



Mr. Edmund Ho Hau Wah, the Chief Executive of Macau SAR, led the Macao delegation to participate in the "Guangdong-Macao Joint Cooperation Conference" in Guangzhou.

Mr. Huang the Hua Hua, Governor of Guangdong Province, and Mr. Edmund Ho Hau Wah, the Chief Executive of the Macao SAR, led the delegations from both sides to attended the "Guangdong-Macao Joint Cooperation Conference 2004" in Guangzhou on 30th November. Mr. Tang Bingquan, the Executive Vice-Governor of Guangdong Province, and Mr.

Francis Tam Pak Yuen, the Secretary for Economy and Finance of the MSAR. reviewed the progress of the cooperation projects carried out last year by the two sides. Moreover, breakthrough in the development of Hengqin Island between the two sides was secured in the Conference. Taking into account the scarcity of Macao's land resources and its imbalanced

industrial structure of overly dependence on a single industry, Guangdong and Macao planned to expand the development of Hengqin Island by the two sides into the establishment of the Pan-Pearl River Delta Hengqin Economic Cooperation Zone jointly developed by the '9+2' provinces and regions. Through the new cooperation mechanism, the industrial structure and the overall employment of Macao can be improved. In addition, Macao's function as a commerce and trade platform for the EU and Portuguese-speaking countries can be developed, and better intermediary services can be provided to the Pan-Pearl River Delta Region.

Guangdong and Macao reached consensus on 11 key areas for cooperation in the next phase:

- Guangdong and Macao work together to promote regional cooperation in the Pan-Pearl River Delta;
- To explore the cooperation between Guangdong and Macao under the framework of the Pan-Pearl River Delta Hengqin Economic Cooperation Zone;
- To cooperate in line with Macao's function as a regional commerce and trade service platform;
- To launch cooperation in the service industry between Guangdong and Macao under CEPA;
- To further facilitate the development of the Zhuhai-Macao Cross Border Industrial Zone;

- To strengthen cooperation in the construction of large-scale transportation infrastructure;
- To strengthen cooperation between the two sides in the tourism sector;
- To support Guangdong enterprises to invest in Macao;
- To intensify cooperation in education between Guangdong and Macao.
- To enhance cooperation of customs checkpoints between the two sides.
- To further cooperation in the fields of science and technology between Guangdong and Macao.

## 3. Seminar and photo exhibition on CEPA and the Certification and Accreditation System"

Macao Economic Services and the Certification and Accreditation Administration of the People's Republic of China jointly held a "Seminar and Photo Exhibition on CEPA and the Certification and Accreditation System" on 11<sup>th</sup> October at the Macau Tower Convention and Entertainment Center. Mr. Edmund Ho Hau Wah, Chief Executive of Macao SAR, and Ms. Wang Feng Qing, chairlady of the Certification and Accreditation Administration of the People's Republic of China, along with relevant officials from the Mainland and Macao, were invited as officiating guests in the inauguration ceremony. Representatives from the local industrial and commercial community also attended the seminar.

The signing of CEPA has created enabling environment for economic and trade exchanges and development of the Mainland and Macao. Under CEPA, trade and investment facilitation is considered the foundation for a smooth implementation of trade in Goods and trade in services. In this event, Mr. Sou Tim Peng, Acting Director of the Macao

Economic Services, signed a Cooperation Agreement with CCIC Macao Company Limited. It is believed that the Agreement will effectively enforce the regulations of China's Certification and Accreditation System, and ensure the economic and trade exchanges between the two places under the framework of CEPA

In the Seminar, officials from the Certification and Accreditation Administration of the People's Republic of China and Mr. Tai Kin Ip, Acting Deputy Director of Macao Economic Services, introduced the National Certification and Accreditation policies, the verification procedures, as well as the implementation of trade in goods in Macao under CEPA. In addition, a photo exhibition was organized alongside the Seminar.
