Editor's Note

The Supplement 6 to CEPA (CEPA 7) was signed in May, setting the stage for further cooperation between the Mainland and Macao in various areas. CEPA 7 deepens the opening of 18 existent service sectors and includes a new sector for preferential treatments, resulting in a total of 41 sectors opened under the Trade in Service of CEPA. Among all those services, 7 sectors will be implemented in Guangdong on an early and pilot basis. Also, starting from July 1, additional 475 products will be added to the existing CEPA Zero-Trariff Product List. Then the total number of Macao-made products eligible for CEPA zero-tariff treatment has reached 1,156.

To further enhance the effectiveness of CEPA for Macao businesses and individuals to enter into the Mainland market, the Mainland has announced new facilitation regulations and measures, including those for the recognition of medical qualification, travel agencies, and certified public accountants.

1. The Supplement 6 of CEPA advances cooperation on various fronts between the Mainland and Macao

Witnessed by the Chief Executive, Mr. Edmund Ho Hau Wah, the Deputy Director of Liaison Office of the Central People's Government in Macao SAR, Ms. Gao Yan, Deputy Director of Hong Kong and Macao Affairs Office of the State Council, Mr. Zhou Bo, Commissioner of the Office of the Ministry of Foreign Affairs of the PRC in the Macao SAR, Mr. Lu Shumin and the Director-General of Macao Customs Service, Mr. Choi Lai Hang, the Supplement 6 to CEPA was signed by the Vice

Minister of Commerce, Mr. Jiang Zengwei and the Secretary for Economy and Finance of the Macao SAR, Mr. Tam Pak Yuen, on behalf of both sides.

The newly signed Supplement mainly comprises measures in three areas, namely, Trade in Services, Trade and Investment Facilitation, and Mutual Recognition of Professional Qualifications.

In the area of Trade in Services, from October 1, 2009, the Mainland will deepen the liberalization in 18 existing sectors, including legal, construction, medical, real estate, placement and supply services of personnel, convention exhibition, public and telecommunications, audiovisual, distribution, banking, securities, tourism, cultural recreational, maritime transport, air transport, and individually owned stores. Also, a new sector, research and development, will be included in the Supplement 6, resulting in a total of 41 services opened under CEPA.

With respect to Trade and Investment Facilitation, in order to enhance the protection of Intellectual Property Rights, the Mainland and Macao agree to adopt measures to strengthen the exchanges and cooperation in the area of Trademarks. Towards this end, the State Administration for Industry and Commerce and Macao Economic Services will establish a communication mechanism to strengthen the cooperation. Major measures of the cooperation content include strengthening exchanges of information in relation to Trademarks and intensifying cooperation of the two sides in personnel training.

On the front of Mutual Recognition of Professional Qualifications, both sides will adopt measures to promote mutual recognition of professional qualifications in accounting and printing services. In the area of accounting, the two sides agree to initiate studies on mutual exemption of certain examination papers in the professional qualification examinations for China Certified Public Accountant and Macao Registered Auditor.

Apart from the above, in the Supplement 6, 8 commitments in 7 service sectors involve Guangdong Province, covering legal, convention and exhibition, public utility, telecommunications, banking, securities, and maritime transport. These measures further strengthen the role played by Guangdong in the early and pilot implementation of CEPA.

2. 475 new made-in-Macao products are eligible for CEPA zero-tariff treatment after July 1

The consultation on the rules of origins of Macao products applying for zero-tariff treatment for the first half of 2009 was convened in Beijing on May 13. Representatives from the General Administration of Customs, the Ministry of Industry and Information Technology, the Ministry of Finance, the Department of Taiwan, Hong Kong, and Macao Affairs of the Ministry of Commerce, Gongbei Office for the Administration of Rules of Origin, and Macao Economic Services, etc., attended the meeting. Both sides reached an agreement during the consultation on the rules of origin for the products that Macao petitioned for zero-tariff treatment for the first half of 2009. Starting from July 1, additional 475 products will be recognized as CEPA zero-tariff products, including food, chemicals, pharmaceutical products, plastics and rubber products, textiles, medical equipment, etc.



Representatives from the General Administration of Customs and Macao Economic Services were engaging in the consultation on the rules of origin for the new zero-tariff products.

Since CEPA came into effect, the total number of Macao products eligible for the zero-tariff treatment has reached 1,156. The Mainland tariff codes and the related rules of origin of those new zero-tariff products are now available on the website of Macao Economic Services (www.economia.gov.mo) and the CEPA exclusive website (www.cepa.gov.mo).

3. The Mainland announced regulations on the recognition of medical qualification for Hong Kong and Macao doctors to practice in the Mainland

The Ministry of Health promulgated the "Administrative Measures for Hong Kong and Macao Doctors to Obtain Mainland Medical Practitioner Qualification Certificates" on April 4. The Administrative Measures stipulates that Hong Kong and Macao permanent residents with Chinese citizenship who meet the requirements of the "Law of the People's Republic of China on Medical Practitioners" and related regulations can apply for the Mainland Medical Qualification accreditation. Categories of medical profession covered for accreditation are clinical medicine, Chinese medicine, and dental medicine. Application criteria are summarized as follows: Hong Kong and Macao permanent residents with medical qualification for at least 5 years before December 31, 2007, obtaining Hong Kong or Macao specialist medical qualification, or have been practicing in medical institutions in Hong Kong or Macao. 4. The State Council of the PRC announced the implementation of the "Regulations on Travel Agencies" on May 1

To strengthen the governance of travel agencies, to protect the legitimate rights of tourists and travel agencies, to uphold the order of tourism market, and to promote the healthy development of the tourism industry, the State Council of the PRC enacted the "Regulations on Travel Agencies" (The Regulations), which has entered into force from May 1. On the other hand, the "Administrative Regulations on Travel Agencies" promulgated by the State Council on October 15, 1996 was revoked. The Regulations are aimed at governing the establishment, foreign investment, operation, supervision and inspection, legal responsibilities, etc of travel agencies. With respect to foreign-invested travel agencies, the Regulations set out that to establish foreign-invested travel agencies, investors should submit applications to competent tourism administrative departments under the State Council, and provide related credentials proving that they have stable operation premises, necessary operational facilities, and registered capital of no less than RMB300,000. According to the Regulations, tourism administrative departments under the State Council should conclude their examination and authorization within 30 days after accepting the applications. 5. The authorization on the investment of Hong Kong and Macao travel agencies set up in Guangdong has been entrusted to the Department of Tourism of Guangdong Province and the Department of Foreign Trade and Economic Cooperation of Guangdong Province

The "Measures for Examining the Applications of Hong Kong and Macao Service Suppliers for Setting Up Travel Agencies in Guangdong Province" (the Measures), approved by the National Tourism Administration and the Ministry of Commerce, came into effect on January 1. The Measures are applicable to the application and examination to set up wholly-own, equity and contractual joint-venture travel agencies in Guangdong Province by Hong Kong or Macao Service Suppliers. In accordance with the Measures, the National Tourism Administration and the Ministry of Commerce entrust the competence to receive and examine the applications of Hong Kong or Macao Service Suppliers to establish travel agencies in Guangdong to the Department of Tourism of Guangdong Province and the Department of Foreign Trade and Economic Cooperation of Guangdong Province, respectively. Qualified Hong Kong or Macao Service Suppliers can submit their applications and related credentials to the Department of Tourism of Guangdong Province. 6. The Mainland will adopt new examination measures for Certified Public Accountants (CPAs) within this year

The Chinese Institute of CPAs has entrusted Macao Society of Certified Practising Accountants to be the enrollment center for the 2009 PRC CPA Uniform Examination for Macao residents. Five people have signed up for the 2009 examination, which will be held from September 19 to 20.

New examination measures are to be implemented this year, while the old system still remains valid for another year. During the transitional period, those who took part in the CPA examinations and obtained passing grade in any subject of the examinations held between 2005 to 2009 before March 23, 2009 are allowed to choose to sit for the examinations under either the old or the new system. The new examination system comprises two phases, namely professional examination and comprehensive examination. Subjects to be included in the professional examination are accounting, auditing, financial and cost accounting, company strategies and risk management, economic laws, and taxation laws. The comprehensive examination, on the other hand, is a general test of the professional capabilities of the examinees. Also, Hong Kong, Macao, and Taiwan residents, as well as foreigners, can be exempted from the examinations of certain subjects set out in the mutual exemption agreement signed according to the mutual beneficial principle between the Mainland and those areas.
