Visit to the Guangzhou Municipal Commission of Commerce

To implement and actively participate in the work on promoting the development of the Guangdong-Hong Kong-Macao Bay Area, as well as to strengthen the exchange and cooperation between the Macao Economic Bureau (DSE) and local commercial authorities in the Bay Area, a delegation of the DSE recently visited the nine Mainland cities of the Guangdong-Hong Kong-Macao Bay Area to meet with the leaders of the local commercial authorities, and visit the Macao-owned enterprises, as well as high and new technology parks in those places. By visiting the commercial authorities of the nine cities of the Bay Area, the DSE hopes to establish close partnerships and



further clarify the future directions of cooperation with them.

In addition, the consultation on the Agreement on Trade in Goods under CEPA officially kicked off with the first Senior Officials' Meeting for enhancement of trade in goods under CEPA convened in Macao on 20 March. In respect of rules of origin (ROOs) consultation, the Consultation Meeting on Specific Issues Related to ROOs for the Agreement on Trade in Goods under the China-Macao CEPA was held between the Mainland's General Administration of Customs (GACC) and the DSE on 25 May in Chongqing to consult on the details of the ROOs-related articles and chapters of the Agreement on Trade in Goods under CEPA.

The Macao SAR Government organised a delegation of Macao entrepreneurs to travel to Portugal and Brazil between 19 June and 29 June for exchange and visit. During the period, Parafuturo de Macau Investment and Development Limited signed a cooperation agreement with Beta-i, a renowned Portuguese incubator, on 21 June at the China and PSCs Economic and Trade Cooperation Business Meeting held in Lisbon, Portugal. Parafuturo will set up a "Macao Interaction Zone" in Lisbon, while both sides can make recommendations to each other on youth startup enterprises moving in to each other's incubation centre. This, accompanied with the launch of the China-PSCs Youth Innovation and Entrepreneurship Exchange Programme, can provide a more precise support to Macao's young business starters for innovating and starting up new businesses in Portugal.

1. DSE visits nine Guangdong-Hong Kong-Macao Bay Area cities

To implement and actively participate in the work on promoting the development of the Guangdong-Hong Kong-Macao Bay Area, as well as to strengthen the exchange cooperation between and the Macao Economic Bureau (DSE) and local commercial authorities in the Bay Area, a delegation of the DSE recently visited the nine Mainland cities of Guangdong-Hong Kong-Macao Bay Area to meet with the leaders of the local

commercial authorities, and visit the Macao-owned enterprises, as well as high and new technology parks in those places.

DSE visited the The Guangzhou Municipal Commission of Commerce, Zhuhai Bureau of Commerce, Bureau of Commerce of Foshan City, Zhongshan Bureau of Commerce and Jiangmen Bureau of Commerce between 28 May and 29 May; and visited the Economic, Trade and Information Commission of Shenzhen Municipality, Bureau of Commerce of Huizhou Municipality, Bureau of Commerce of Dongguan City and Bureau of Commerce of Zhaoqing City between 11 June and 13 June. During the visits, the Mainland commercial authorities gave an account on their areas' latest business and investment development opportunities and roles in the development of the Bay Area; both sides discussed and exchanged views on topics including customs clearance facilitation,

streamlining of inspection and quarantine measures, and optimisation of trade in services and trade in goods.

Framework The Agreement Deepening Guangdong-Hong Kong-Macao Cooperation in the Development of the Bay Area has established the objectives of cooperation in the development of the Bay Area, which include advancing Macao's development into a commercial and trade cooperation service platform between China and Portuguese-speaking countries, promoting facilitation of flows of people and goods by means of enhancing the level of customs clearance facilitation, so as to boost mutual investment between Mainland and Macao enterprises, and to encourage people in Macao to invest, start up new businesses and work in Guangdong. Chan Tze Wai, Deputy Director of DSE, says as Guangdong and Macao have been maintaining close relations and have signed the related cooperation agreements, it is believed that there will be wider room for cooperation between the Mainland and Macao in trade and investment areas on such an ideal basis following the imminent promulgation of Guangdong-Hong Kong-Macao Bay Area's development plan. Macao will give full play "One Centre. One Platform" to advantages to further promote optimisation of trade and investment facilitation with the Mainland, to provide SO as more development opportunities to enterprises in the two places and to accelerate the integration into the Bay Area's development.

During the trip, the delegation visited the Guangdong-Macao (Jiangmen) Industrial

Cooperation Demonstration Zone, where they learned about the planning of the support areas of the Yamen Electroplating Industrial Base and the investment of the Macao-owned enterprises, and paid visits to Macao food products manufacturers investing in Jiangmen. The delegation also visited the Shenzhen Bay Eco-Technology Park, Huizhou Tonghu Ecological and Smart Zone, Dongguan Songshan Lake High-Tech Zone and Zhaoqing New District to get informed about the investment environment and development prospects of those zones and parks under the development of the Guangdong-Hong Kong-Macao Bay Area.

By visiting the commercial authorities of the nine cities of the Bay Area, the DSE hopes to establish close partnerships and further clarify the future directions of cooperation with them. Based on the principle of achieving complementary development and a win-win environment, all sides will deepen the regional cooperation in order to contribute together to the Guangdong-Hong Kong-Macao Bay Area's economic development and establishment.

2. Consultation on trade in goods and trade facilitation under CEPA begins (Chongqing and Beijing)

The consultation on the Agreement on Trade in Goods under CEPA officially kicked off with the first Senior Officials' Meeting for enhancement of trade in goods under CEPA convened in Macao on 20 March. In respect of rules of origin (ROOs) consultation, the Consultation Meeting on Specific Issues Related to ROOs for the Agreement on Trade in Goods under the China-Macao CEPA was held between the Mainland's General Administration Customs (GACC) and the Macao Economic Bureau (DSE) on 25 May in Chongqing to consult on the details of the ROOs-related articles and chapters of the Agreement on Trade in Goods under CEPA. In-depth communication and discussion were made over technical issues such as wholly

obtained or produced goods, regional value content, de minimis, accumulation, and ROOs verification.

In respect of consultation on customs clearance facilitation, the Meeting of Task Group on Trade in Goods Facilitation under CEPA was held on 14 June in Beijing between a Macao delegation, comprised of of DSE. representatives the Macao Customs, Civil and Municipal Affairs Bureau (IACM) of Macao and Macao Trade and Investment Promotion Institute (IPIM), and representatives of China's Ministry of Commerce, Hong Kong and Macao Affairs Office. GACC. Certification and Accreditation Administration and other authorities. At the meeting, both sides reviewed the achievements in the trade

facilitation implemented with their joint efforts. Besides, the Macao side relayed fully the appeals of the business community, based on their actual needs, to the Mainland authorities. Both sides also carried out sufficient communication as they exchanged views over topics such as customs clearance facilitation, inspection and quarantine and customs procedures.

3. Macao entrepreneur delegation visits youth entrepreneurship projects in Portugal and Brazil

4. DSE takes the gold and jewellery sector to visit Jieyang in search of business opportunities

To fulfil the role of the task force on services sector cooperation between Guangdong and Macao under CEPA on the basis of the Framework Agreement on Guangdong-Macao Cooperation, as well as to promote exchange and cooperation between the services sectors of Guangdong and Macao, the Macao Economic Bureau (DSE) took a total of some thirty representatives of Macao's gold and jewellery sector to visit Jieyang in eastern Guangdong between 26 April and 27 April for site visits to the nationally-renowned jade polishing and wholesaling centre, as well as exchanging and connecting with local counterparts.

Dubbed as "China's Jade Capital", Jieyang is famous for its polishing facilities and craftsmanship, and is a specialised industrial area combining polishing and trade of jades. Macao's gold and jewellery sector is the backbone of the local retail services sector, with its sales securely occupying over twenty percent of Macao's total retail sales. It is also a major sector for Macao's economic development.

Coordinated by the Department of Commerce of Guangdong Province and arranged by the Jieyang municipal government and Bureau of Commerce of Jieyang, the group of representatives were presented with exhibitions of high-end jade polishing, carving and other finishing processes and processes of white jade cutting and finishing, and visited the raw jade trading market, sales market and jade products e-commerce live broadcast centre. The group also paid a visit to Jieyang's jewellery and jade trade association to conduct exchanges over the development of the gold and jewellery sectors of the two places with around thirty local enterprise representatives, and to make focused discussions on topics such as how to Jieyang's integrate design and craftsmanship with Macao's well-developed international tourism consumption market, favouring the establishment of mutually beneficial cooperation relationships.

This tightly scheduled and fruitful activity has effectively built a cooperation platform for both sides' gold and jewellery retail services sector to establish interconnections for future business exchanges that will benefit the sector in

exploring sources of supply, markets and businesses, helping the enterprises' development substantially.

5. Working Group on Enhancing Hong Kong/Macao Economic Cooperation meeting held in Hong Kong

To promote the economic development of Hong Kong and Macao, the Working Group on Enhancing Hong Kong/Macao Economic Cooperation held this year's meeting in Hong Kong in the afternoon of 5 June. Both sides agree that both Hong Kong and Macao have their own unique advantages to play indispensable roles in the national development and to complement each other. The development of the Guangdong-Hong Kong-Macao Bay Area, in coordination with the development strategies of the "Belt and Road" Initiative, will provide historic opportunities for the economic development of the two places. Hong Kong and Macao will strengthen the cooperation in areas such as economic activities. tourism and investment promotion, and explore new room for development.

To further deepen the economic cooperation between the two places, both sides will launch the cooperation in the areas

of legal transparency and technical trade barriers according to the Economic and Technical Cooperation Work Programme under the HK-Macao CEPA.

Moreover, the development of the Guangdong-Hong Kong-Macao Bay Area bring the tourism sector new will development opportunities. Both sides will continue to develop more Guangdong-Hong Kong-Macao multi-destination tourism products; meanwhile, by taking opportunity the opening the of of Hong Kong-Zhuhai-Macao Bridge, jointly explore the launch of cooperation in tourism as part of the "Bridge Economy". In respect of investment promotion, both sides will continue to join forces with Guangdong Province promote investment to opportunities and carry out marketing initiatives abroad, so as to attract more overseas institutions to invest in the region. They will also continue to provide referral consultancy services for mutual and investment between investors of the two places through the liaison mechanism between them

This meeting was jointly chaired by Tai Kin Ip, Director of the Economic Bureau of the Macao SAR Government (DSE), and Bernard Chan Pak-li, Under Secretary for Commerce and Economic Development. Other representatives of the Macao side include Maria Helena de Senna Fernandes,

Director of the Macao Government Tourism Office, Chan Tze Wai, Deputy Director of the DSE, and Vong Vai Lon Agostinho, Member of Executive Committee of the Macao Trade and Investment Promotion Institute (IPIM); the Hong Kong side is comprised of representatives of the Commerce and Economic Development Bureau, Invest Hong Kong, Tourism Commission, Hong Kong Tourism Board and Trade and Industry Department.

6. Guangdong-Hong Kong-Macao Bay Area Macao Youth Entrepreneurship Exchange Tour

To encourage the youth of Macao in integrating themselves into the development and progress of the Guangdong-Hong Kong-Macao Bay Area. Guangdong-Hong Kong-Macao Bay Area Macao Youth Entrepreneurship Exchange Tour, hosted by the Macao Economic Bureau (DSE) and co-hosted by Parafuturo de Macau Investment and Development Limited, was successfully held between 12 April and 14 April of 2018 with the participation of 42 representatives of Macao's youth associations and youth startup enterprises. During the 3-day study visit. the Tour visited the entrepreneurship incubation bases in 5 cities

in the Guangdong-Hong Kong-Macao Bay Area, including Zhongshan, Guangzhou, Zhuhai and Shenzhen, which have signed youth entrepreneurship cooperation agreements with the Macao SAR Government, as well as Hong Kong's Cyberport, with which the cooperation is being planned to be strengthened and advanced.

During the activity, the Macao Youth Entrepreneurship Exchange Tour site visited the cities' youth entrepreneurship incubation centres and facilities designated for Hong Kong and Macao. Apart from getting informed on-site about the vouth entrepreneurship support policies different places, they also focused on strengthening the exchanges and connections with local youth startup enterprises. During the meetings, young business starters from the Mainland and Hong Kong shared their stories and experiences of entrepreneurship, which were highly beneficial to the personal development of the participating representatives from Macao, and facilitated each of the sides to establish connections and expand its business network in order to

7. CPDFund Internship Programme officially launched

Since having its headquarter successfully settled in Macao last year, the China-Portuguese Speaking Countries Development Cooperation and Fund (CPDFund) has been assisting Macao in establishing itself as a commercial and trade cooperation service platform between China and Portuguese-speaking countries actively capitalising on its advantages, of which one is the provision of internship opportunities to Macao's financial sector

practitioners. Five trainees of the CPDFund Internship Programme departed for Beijing on 8 April this year to undergo internship training for periods of 3 months and 9 months. The internship trainees, who were recommended by the Monetary Authority of Macao (AMCM) and the Macau Association of Banks, have multiple years of finance-related work experiences. The units include China training the Development Bank and the China-Africa Development Fund, and on-the-job training is carried out in their legal, risk, marketing and project assessment departments. The aim of the Internship Programme is to nurture talents for assisting the future development of Macao's featured finance through participation in actual work that will enable acquisition of experience, broadening of vision and enhancement of professional knowledge.

To enable small and medium enterprises (SMEs) to get a better grasp of cross-border e-commerce skills, the DSE organised the Cross-border E-commerce Marketing Strategy Workshop from 9 June to 10 June by

inviting four cross-border e-commerce professionals, including Chen Haiquan, Director Guangzhou's Asia-Pacific E-commerce Institute, Huang Yiyan, Operation Director of NetEase POP, a Mainland cross-border e-commerce platform, Deng Hui, Marketing Director of Guangzhou D-MCARK, an e-commerce agency, and Ma Jun, Executive Vice President of the Sino-Portuguese E-Commerce Chamber, to share the frontline information on cross-border e-commerce, popular e-commerce marketing strategies and practical skills with Macao's business sector.

Attendees of this activity are mainly owners of SMEs in Macao engaging in retailing. They expressed a high level of interest in exploring the Mainland market, and reckoned that the workshop was helpful in understanding the current development trend and opportunities of the Mainland's cross-border e-commerce, as well as how to develop Mainland business with precise

promotion and marketing strategies by leveraging on e-commerce agencies. Making a positive effect on boosting Macao's e-commerce development, this activity has deepened the business sector's understanding of the development trend of cross-border e-commerce, and has helped Macao's SMEs to explore the enormous Mainland market as well.
