

External Trade of Macao in the Fourth Quarter of 2022

Overview


External merchandise trade of Macao totalled MOP40.96 billion in the fourth quarter of 2022, down by 6.9% from the MOP43.99 billion in the same quarter of 2021. Merchandise imports contracted by 8.1% to MOP37.57 billion and merchandise exports went up by 8.4% to MOP3.39 billion. The exports-imports ratio rose by 1.4 percentage points year-on-year to 9.0%. Merchandise trade deficit narrowed from MOP37.74 billion in the fourth quarter of 2021 to MOP34.19 billion.

Total Exports

Total merchandise exports rose by 8.4% year-on-year in the fourth quarter of 2022, with domestic exports dropping by 8.3% but re-exports rising by 11.8%.

Analysed by destination, merchandise exports to Singapore (MOP125.1 million), Viet Nam (MOP36.5 million), mainland China (MOP343.8 million), Hong Kong (MOP2.52 billion) and India (MOP16.0 million) expanded by 345.2%, 54.3%, 17.6%, 7.0% and 0.7% respectively. On the other hand, exports to Japan (MOP1.8 million), the EU (MOP23.4 million) and the USA (MOP111.9 million) slipped by 91.9%, 48.4% and 34.9% respectively.

Exports of machines & apparatus, parts & accessories thereof, the leading export commodity, increased by 55.3% to MOP873.7 million, accounting for 25.8% of the total exports. Exports of tobacco & wine and electronic components swelled by 53.8% and 14.0% respectively, whereas exports of garment & textile products, watches, diamond & diamond jewellery and copper & articles thereof shrank by 24.9%, 21.9%, 4.5% and 2.0% respectively. By contrast, exports of other products rose by 6.1%



Domestic Exports

Domestic exports amounted to MOP491.6 million (14.5% of total exports), down by 8.3% year-on-year but up by 3.8% quarter-to-quarter. Hong Kong was the largest market of Macao's domestic exports (28.0% of total domestic exports), with the corresponding value of exports dropping by 13.0% year-on-year. Value of exports to Singapore, Viet Nam, mainland China and India rose by 159.1%, 18.0%, 5.7% and 2.4% respectively, while that to the EU and the USA fell by 58.9% and 34.8% respectively. Analysed by type of commodity, exports of garments (18.8% of total domestic exports) dropped by 34.2%, of which exports to Hong Kong (4.9% of total domestic exports of garments) went up by 0.1% and the USA (83.6%) went down by 34.6%. Exports of tobacco (6.2% of domestic exports) and copper & articles thereof (21.5%) dipped by 48.7% and 2.3% respectively; meanwhile, exports of other products (53.5%) increased by 15.2%.

Domestic exports to mainland China rose by 5.7% to MOP85.7 million (17.4% of domestic exports), of which tariff-free merchandise exports under the Mainland and Macao Closer Economic Partnership Arrangement (CEPA) increased by 32.0% to MOP35.7 million, consisting mainly of copper-clad boards (56.7% of total). The amount of tariff saved totalled MOP1.5 million

Re-exports

Total value of re-exports increased by 11.8% to MOP2.90 billion (85.5% of total exports) in the fourth quarter of 2022. Hong Kong was the largest market of Macao's re-exports (82.1% of re-exports), followed by mainland China (8.9%). Value of re-exports to mainland China and Hong Kong grew by 22.2% and 8.4% respectively, while that to Japan declined by 85.7%. In terms of


types of commodities, re-exports of raw materials & semi-manufactures (7.5% of re-exports) expanded by 29.2% while those of consumer goods (49.4%) reduced by 2.7%; besides, re-exports of other products (43.2%) rose by 31.3%.

Imports

Total value of merchandise imports fell by 8.1% year-on-year to MOP37.57 billion in the fourth quarter of 2022. Mainland China was the main supplier of goods imported to Macao (31.1% of total imports), and the value of imports dropped by 2.7% to MOP11.70 billion. As regards other places of origin, value of imports from the Republic of Korea (1.3% of imports) rose by 2.5%. By contrast, value of imports from Japan (6.2%), the EU (30.7%), the USA (6.5%), Switzerland (6.7%) and Hong Kong (4.0%) dipped by 30.9%, 17.8%, 16.5%, 10.0% and 2.4% respectively.

Regarding the types of commodities, imports of fuels & lubricants (3.9% of total imports) and raw materials & semi-manufactures (8.2%) rose by 10.3% and 9.8% respectively, whereas those of consumer goods (71.1%) and capital goods (16.8%) slid by 12.0% and 1.0% respectively.

Imports of consumer goods showed a year-on-year decrease; imports of food & beverages (16.1% of total imports) and gold jewellery (7.5%) climbed by 31.2% and 2.4% respectively, whereas imports of beauty, cosmetic/skin-care products (11.8%), motor cars & motorcycles (0.9%), clothing & footwear (8.8%), watches (6.5%) and handbags & wallets (6.4%) reduced by 39.4%, 19.4%, 16.0%, 13.6% and 13.2% respectively. In addition, imports of other consumer goods (13.1%) dropped by 14.0%.
